Safety Corner



Incident Response Safety

Security has the potential to respond to a variety of incidents. Some have the possibility of being hostile such as, a trespasser, an employee termination, a dispute between coworkers, and so forth.

During this COVID-19 outbreak, tensions may be running higher than usual with some persons who come to the officer's post, whether authorized or not.

Therefore, the officer cannot ever let their guard down when it comes to responding to any type incident.

Things to consider when it comes to officer safety during a response are:

- Assess the scene for safety from a distance. Look for hazards or potentially hazardous situations that could arise.
- Ensure your security supervisor is aware of the incident you are responding to, if they are not already aware, and provide pertinent details before moving in to address the situation.
- Request assistance as needed such as additional security, the security supervisor, law enforcement, etc., before entering the affected area.
- If your senses tell you the situation is not safe to become involved with, listen to them.

Always maintain your professional bearing, regardless of the demeanor of others involved in the incident.

If you have any questions about how to safely respond to an incident, or potential incident at your post, be sure to contact your supervisor for direction before you become involved with one.
